IMPORTANT VISA REGISTRATION INSTRUCTION FOR RUSSIAN VISITORS



According to Russian law, you must register your visa within 72 hours of arrival, at EACH city. The specific procedures and conditions depend on the type of visa that you have and the city you are visiting – see below for details.

The registration stamp is imprinted on the **WHITE IMMIGRATION CARD** that you will be given upon crossing the Russian border. **HOLD ON** to this card because you will need to show it upon leaving the country. If your stay in any city is less than 72 hours, you do not need to register, but you should be prepared to show your itinerary to explain why you do not have a registration stamp for that city.

Tourist or Single Entry Business Visa

HOTEL STAY- Your hotel will automatically register your visit – ask the front desk.

APARTMENT STAY – For both Tourist and Business visas, the visa must be registered by your landlord. The landlord will need to fill out a notification form and include your passport and immigration card details. They can show up in person at, or mail the registration form to the nearest OVIR (the Russian Government Office of Visas and Registrations) or local police precinct. The registration form has two parts. The main body of the form is given to the authorities, and the other is torn off and given to you. Keep this form with you at all times, in case you are asked for it.

If your stay is outside Moscow or St Petersburg, you will need to register, within 72 hours, at the local OVIR in the city where you will reside. While in Russia, if you need a formal letter of introduction for OVIR, which we can provide at no charge, or if you have any other questions, please contact our Moscow office.

Multi Entry Business Visa

Multi Entry Business Visas can be registered only in the Moscow office Please leave time in your schedule during your first visit to stop by the office and register.

Restricted Cities

The following cities are considered "restricted" and have a somewhat complicated registration procedure: **Kazan, Samara, Vladivostok, Habarovsk, Irkutsk, Barnaul, Petropavlosk-Kamchatsky, Petrozavodsk, Sahalin, Stavropol, Perm** and **Rostov.** We have affiliate offices in each of these cities that provide registration assistance. *If you are traveling to any of the above cities, please call our Moscow office for assistance.*

Visa Terms

Your visa is good only for the period stated on the visa, and it cannot be extended while you are in Russia. Should an emergency prevent your timely departure, please contact the Moscow office as soon as possible.
